## **Membership Fee Regulation bylaw of the Cannabis Club Kleve e.V. As of: 20.06.2024**

**§1** All club members pay a membership fee. The membership fee is charged annually.

**§2** Membership begins with the written confirmation (also possible electronically, provided the member does not object) of membership by the board and receipt of the annual membership fee

**§3** Members grant the association a SEPA direct debit mandate for the purpose of collecting contributions or transfer the amount to the association account. Payments received are documented by the treasurer (m/f/d).

**§4.1.** The one-time basic fee for membership is €20.00 per year of membership

**§4.2.** The intended purpose must be stated as “annual membership fee for (name, first name of the club member).

**§5** If a member has not paid their fee for the calendar year, they will be warned by the board. If the annual fee is not paid despite a reminder, the board will inform the member of the threat of exclusion due to late payment. If no payment is made, the board will exclude the member after a reasonable period of time.

**§6** The club surcharge per gram of cannabis is set at 5 euros, including statutory sales tax. The club surcharge added to the production costs results in the final price. The surcharge can be paid in cash or by card upon collection from the clubhouse.

**§7** These contribution regulations can be changed by resolution of the board.
